Since 1984, the Food Bank for Larimer County has worked to end food insecurity in Larimer County through outreach, education, and food distribution. During the fiscal year end 2024, we provided enough food for more than 10 million meals to over 50,000 individuals in need. Most recent data from Feeding America (2022) tell us 11% of Larimer County's population faces food insecurity.

The high cost of food continues to place further strain on families struggling to make ends meet and choosing between utility bills and grocery bills. Food prices rose almost 2.5% nationwide between November 2023 and November 2024 according to the most recent consumer price index (CPI) report from the Bureau of Labor Statistics. Government and economic changes impact people at an individual level; sadly, we know what it looks like when people and families don't have what they need to flourish in their daily lives.

We are proud of the work we do, but we don't do it alone. It takes partners, donors, supporters, a community—and YOU—to achieve our goals each year. This report provides a transparent look at our work by the numbers. These numbers, year to year, help us assess whether we are meeting our goals and making realistic new ones.

The mission at the Food Bank for Larimer County is to provide food to all in need through community partnerships and hunger-relief programs. And, while we expand and improve our outreach, programs, and services, we continue to rely on public support in our vision for a hunger-free Larimer County.

We partner with Volunteers of America (VOA) to provide nutritious meals to people 60 years of age and older. We create made-from-scratch meals that are distributed to seniors at multiple sites throughout Larimer County. Through our Fresh Food Share No-Cost Markets, we also distribute food provided by the United States Department of Agriculture's Commodity Supplemental Food Program (CSFP).

FOR KIDS

Free meals and snacks are provided to school-aged children throughout Larimer County via our Kids Cafe program. We give kids snacks and lunches all year long through community partners and directly through our programs and services. During summer school-off days, we operate a mobile Lunch Lab that visits multiple sites in Larimer County.

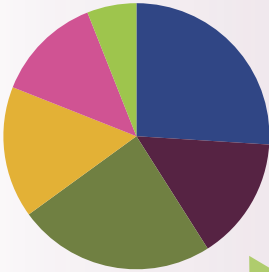

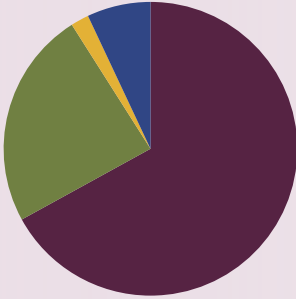

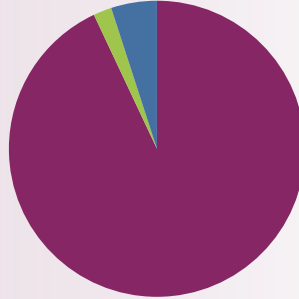

Joanne

"My experience at the Food Bank has been great. The food we get here helps my family so much, especially over the last year and a half," Joanne said. "I also love receiving the recipes that they give out. I can go home and make a whole meal out of what they provide!"



Ronda

The first time Ronda visited the Food Bank to get food, she found herself in tears. "I thought that I didn't belong here," she said. "I thought I was taking resources from someone else. A lady took me aside and said, 'You're the people we serve. You're part of our community. You shouldn't feel ashamed.'" That moment made a huge impact on Ronda. Since then, she said she's never been hesitant to share what a great resource the Food Bank can be.

Ron

"Without the Food Bank, I would have very little as far as food goes," said Ron. "I'm just trying to piece together meal to meal, day to day." Ron is retired from a decades-long career in the housing industry doing handyman work. He and his wife of 18 years live solely on his fixed income. He expressed frustration at the challenges that high living costs and inflation have placed on hard-working families. "This isn't the America I grew up in," Ron said.
